The Senior Environmental Engineer reports directly to the HSE Division Manager along with a Senior HSE Engineer, a Senior Safety Engineer and a Senior Occupational Health Specialist. The major challenge for the Senior Environmental Engineer is to strive imaginatively for the continuous improvement of environmental performance. The jobholder must exercise judgment on appropriate policies, standards and actions in an industry with a high technical complexity and inherent environmental risks. Local culture and public opinion is becoming increasingly aware of environmental issues and this requires the balancing of the long-term cost of environmental policies with the benefits in terms of reduced environmental risks. A wide range of internal contacts (from individuals to Division Managers) and external contacts is required to ensure compliance with

standards, development of best practice and enhancement of Company reputation.

Main accountabilities:

- To support the provision of independent technical expertise on all aspects of Environmental Management.
- To support the development and implementation of Environmental Management Systems and, through line management, achieve the environmental goals and objectives of the Company.

- To develop and support the implementation of air quality monitoring, measurement, sampling, and dispersion modeling.

- To analyze and evaluate Company environmental performance through accurate and timely reporting against plans/targets.
- To support the investigation and appraisal of environmental incidents and to develop remedial actions to reduce environmental risks.
- To manage environmental audits of Company operations and facilities. To ensure that audits are completed on schedule and that resultant action plans are implemented.
- To support actions to ensure that Contractors manage their environmental performance in accordance with Company policy.

- To ensure that environmental protection is managed with the diligence accorded to other critical business (establishment of Environmental Management as a critical business activity is required).
